**Purpose:** 

The purpose of the workshop is to share information, examples of best and proven practices and enhance the capability of Arab states to establish an awareness of the procedures of radioactive sources safety and physical protection and familiarize professionals, involved in the establishment of a system of physical protection with current concepts and techniques and increase safety and security awareness in individuals and organizations that will give physical protection of radioactive sources issues attention warranted by their significance.

The workshop strategy will provide Arab trainees with modern and internationally accepted concepts and technology in the area of Safety of radioactive sources and physical protection.

#### **Information:**

growing concern in the region over the potential of sabotage, terrorism and the risks of illicit trafficking of nuclear materials and radioactive sources, AAEA seeks to strengthen the Arab capabilities of physical protection, safety and security of radioactive sources. The Arab States need to establish and maintain stable and effective physical protection regime in order to guarantee a high level of security of all nuclear facilities, materials and radiation sources. This workshop comes to address these broad issues and to raise the public and professionals awareness.

This workshop consists of lectures and small-group working sessions. The workshop is presented in the same sequence as that in which the physical protection principles should be applied in the process of physical protection design and analysis.

### **Participation:**

The workshop is open to thirty (25) participants from Arab States. The participants' expenses of nominees from AAEA member states will be covered by the organizers of the workshop.

## Participants' **Qualifications:**

The workshop is intended mainly for individuals from operating organizations and regulatory bodies, who are in charge of the safety of radioactive sources and nuclear installations physical protection. Representatives of other organizations may attend workshop, as their needs require, their background permit and space is available.
